



Official Realty Inspection Application Private Water Systems

1. Please make sure payment accompanies the Realty Inspection Form or make arrangements to drop the form off to our department **prior to** the time of the inspection.
2. Water samples are collected on Monday and Wednesday afternoons. Allow 5 working days for the basic report to be completed, faxed or mailed. NOTE: A water sample will NOT be obtained if the well is in violation of code and/or additional repairs or upgrades are required.
3. Provide as much information as possible regarding the location and type of water system. The homeowner or a designated agent should be present at the time of inspection to verify the locations of the system and answer any questions as needed.
4. If the financing is VA, HUD, FHA, or USDA additional water testing may be required (ex. lead, nitrate, nitrite etc). It is the responsibility of the homeowner or agent to determine what tests will be required. Additional testing can delay completion of the report.
5. Water supply and water treatment devices are located and evaluated to confirm proper conformity with the state Health Department rules. Water samples are taken to test for the presence of coliform bacteria. Positive water samples require chlorination of the well and re-sampling (an additional fee is required). If the well is buried, a well alteration permit may be needed. The well must then be re-inspected before final approval will be given.

Inspection authorization must be owner/ legal power of attorney/ owner's representative and/or purchaser (buyer)
