

Property Improvement Permit [P.I.P] & Demolition Permit

What is it?

P.I.P/Demolition Permit is issued by the Wood County Health Department to property owners whose home is being serviced by a well and/or septic system. This will assure that any proposed new construction or remodeling on a property (additions, garages, pole-barns, etc...) does not infringe on the isolation distance requirements per the Ohio Administrative Code. It is also part of an **Operation and Maintenance** program that has been implemented by the Wood County Health Department and mandated by the Ohio Department of Health Rules governing private sewage systems.

A permit is also required to obtain a demolition permit. This will assure that proper well and/or septic abandonment is performed and documented **prior to** the structure being demolished.

When will it be issued?

This permit is issued **prior to** obtaining a building/demolition permit from the Wood County Building Department. You cannot obtain a permit from the Wood County Building Inspection Department until a P.I.P/Demolition permit has been issued to you by the Wood County Health Department.

How do I obtain a permit for any proposed new construction?

- 1) Contact the Wood County Health Department Environmental Division (419-354-2702).
- 2) Provide the health department with a site plan outlining the exact location and dimensions of the proposed new construction as well as the proximity to your well and/or septic system along with the name of the proposed contractor (builder) if applicable.
- 3) Schedule an appointment with the inspector to evaluate your proposed site plan.

How do I obtain a permit for the demolition of a structure?

- 1) Contact the Wood County Health Department Environmental Division (419-354-2702).
- 2) Locate the well and/or septic tank. <u>NOTE</u>: The health department may be able to provide a record of the location of the septic system and/or well for the property in question if you are unaware of their exact location.

Well Abandonment

- If a well is to be abandoned a **Well Abandonment Permit** is required to be obtained through the Wood County Health Department. <u>There is no permit fee required</u>.
- Properly abandon all wells per the Ohio Department of Health rules governing private water systems [Section 3701-28 of the OAC].
- Submit a copy of the <u>Well Abandonment Form</u> to this department.

Septic Abandonment

- Properly abandon the existing septic tank per the Ohio Department of Health Rules governing Private Sewage Systems [3701-29 of the OAC]. The application fee for the **Septic Tank Abandonment** permit is \$140.00.
- Submit a copy of the <u>Septage Pumping Report Form (manifest/receipt)</u> to this department.
- Submit a copy of the state of Ohio Department of Health <u>Sewage Treatment System</u> <u>Abandonment Report</u> to this department.

<u>**REMINDER</u>**: Proper abandonment(s) must be completed and completed documentation received **prior to** the issuing of a demolition permit.</u>

What are the permit fees?

A fee of \$50.00 is required for each P.I.P/Demolition permit issued. This includes the initial site visit and the follow-up letter/correspondence to the Wood County Building Department as needed.

The **<u>Operation and Maintenance Permit</u>** is \$115.00 and will be good for a period of five (5) years.

An additional fee of \$50.00 may be required to cover the cost of any additional follow-up and /or re-inspections.

NOTE: * Once a site evaluation has been conducted, all well and/or septic violations must be corrected even if you no longer wish to pursue your proposed construction project.
