## **Health Commissioner update:**

Ben spoke about a State of Ohio Cooperative Purchasing Program to assist in saving of money with purchasing go goods as well as services. We are hoping to have this as a resolution at the November meeting. A discussion was also held with the board of a proposal for usage of the COVID19 contact tracing funds and the plan to hire 25+ additional staff members for contact tracing. This will meet the demand for tracing and will also include supervisors, call center staff and outreach staff for guidance calls. Contracted staff will also be pursued. These will all be full-time and will be remote.

The board was also informed of partnership between bars, BG City and BGSU and the first set of guidance statements that will be placed on poster's for distribution as well as weekly talking points to be shared around. There will also be promo videos created and shared. More information will be coming out.

A lengthy discussion was also held regarding the upscale of cases the last couple weeks and future pop up testing and layouts with locations for wood county. More information to come about this as well.
