I. BOH Questions / comments:

- A brief discussion was held regarding dental numbers. CEO Diane Krill stated the actual appointment slots changed which affected new patients seeing the dental hygienist adding more support is being looked at. Cathy Nelson also suggested contacting local dentists in the area for those Medicaid or non-pay patients that may be looking for a provider which can provide services to them.
- Cathy Nelson requested an update from BGSU Chief Health Officer, Ben Batey. Ben stated case
 numbers have stayed fairly low and navigation continues adding the HD staff had visited the BGSU
 field house as part of planning for a combined effort with future mass vaccination clinics at the end
 of March.

II. Health Commissioner:

- Ben Robison reports the HCNO contract, Community Health Assessment, was discussed with Mercy Health in Perrysburg to join as a financial partner per the recommendation of the board and although Mercy Health declined they stated possible consideration in the future. This contract was executed as the board's previous approval with question selection process starting this day. The schools have agreed they can be a part of the youth behavior risk assessment as in the past adding the data should be interesting due to COVID19.
- Case numbers are increasing, about 130 cases per 100,000, adding to please help to encourage the community to not let their guard down. Vaccines are going well with nearly 21% of Wood County being vaccinated; breaking down: 75% of the 70-74-year old's, 72% of 80 +; 73% of the 75-79-year old's and 64% of the 65-69-year old's. Doses are not stock piled and continue to be moved as quick as we get them. Efforts continue working with Committee on Aging for those whom are home bound and Job and Family Services for targeted outreach.

Ben commented the ODH notice of award has not yet been received, however, additional funds will be reimbursed through FEMA that is eligible for COVID response with additional funding being requested. This money will be used to hire additional help when the surge in vaccine being received. Support will be for scheduling appointments, data entry to state impact SIIS, vaccinator's and lead vaccinators, clinic coordination and operations lead, partner liaison and recruitment, web support as well as staff writers. Ben requested board approval to proceed with this request to apply to FEMA as well as identifying with the above positions. Should these applications be denied he would request the potential to use levy dollars which would be approximately about \$170,000 to \$180,000 which would cover to the end of July. Tom Milbrodt stated he is in complete support and agreement and there is probably not a bigger need to get these things done, Betty Woods added she completely agrees with Tom and that we need to get this done.

Resolution #FIN-12-03-2021

Motion authorizing the use of levy funding should FEMA funding not be received.
