# Motion to Revise the Compensation Terms for the Vaccinator MOUs.

The updated terms would compensate contractors at the rate of \$50 per dose of COVID vaccine administered in a POD or clinic setting, regardless of the type of dose, e.g., adult primary, pediatric primary, or booster dose. Non-compensatory terms in the MOU may continue be adjusted as needed, pending Prosecutor's approval. DJ Mears seconded the motion. A roll call vote was taken. *Motion passed*

# Resolution CMY-01-11-2021

# **Updates and Reports**

Cathy Nelson announced the nominating committee has nominated Nilgun Sezginis as Vice President. DJ Mears seconded the motion. A voice vote was taken. *Motion passed* 



DJ Mears commented whether the tabled motion needs a time frame added. Richard Strow commented this could be any length of time and a motion would need to be made to be removed from the table before being voted on.

Director Updates: Lana Glore welcomed and introduced Ghassan Tafla as Assistant Environmental Health Specialist. Ghassan gave a brief introduction to the board.

Kim Hertzfeld was welcomed as a new board member appointed by Perrysburg. Kim provided the board with a brief introduction.

#### II Health Commissioner

- a. CMS Vaccine Requirement: Ben informed the board and discussion was held regarding a CMS Vaccine rule stating CMS regulated facilities be required to implement processes regarding staff vaccinations in order to continue receiving Medicare or Medicaid funding. There must be a process in place assuring all eligible staff are vaccinated or a process be in place which they can seek exemptions and the facility make accommodations for those receiving exemptions to safely work as well as a place for documenting vaccination status and compliance within a CMS regulated facility. Timelines established for vaccinations or exemptions: One dose shot series must be received by all eligible staff on or before December 6 OR the two-dose series be completed by or on January 4<sup>th</sup> with the second dose completed by this date. This ruling is being reviewed by the Prosecutor to determine if this is affecting the Health Center only or as a whole as a Department. There will be a special board meeting scheduled to determine the next action to be taken.
- b. Health Department building discussion: Board discussed and agreed to obtain quotes to expand the HPP space, add in an operation center/meeting area and expand out the Environmental area to become offices which would expand west and south to the sidewalk.
- c. COVID-19 update: Ben announced cases have been steadily increasing since October. The State of Ohio did award the Health Department with funding that will cover emergency responses efforts thus far as well as FEMA funding which will also be covering the most if not all the vaccine costs. Ben also announced the State is currently focusing on mental health support programs due to the impact from this Pandemic and its duration. He will be participating with the first meeting at the end of the month.

#### III Board of Health questions / comments

Bob Midden made a motion to adjourn at 7:59pm. Dallas seconded the motion. A voice vote was taken. *Motion passed*
