PROGRAM - Rachel Bowlus (15 minutes)

PRG-01-09-2022 Motion to grant a home sewage treatment system (HSTS) variance for 5546 Dindore Road, Perry Township

Rachel Bowlus made a motion to grant a HSTS Variance for 5546 Dindore Road, Perry Township. The variance is permitted by the Ohio Department of Health Home Sewage Treatment System Rules, Ohio Administrative Code 3701-29. The variance request was made by the homeowner due to lot size limitations resulting in regulations not being met in regard to isolation distances and leach field design. PRG-02-09-2022 Motion to approve Memorandum of Understanding with Family Alliance Counseling LLC

Rachel Bowlus made a motion to approve the Memorandum of Understanding with Family Alliance Counseling, LLC (FAC) to establish a partnership on peer reviews for Behavioral Health to mutually promote and carry out the proposed peer review and quality improvement efforts at the health center and will be at no cost to either party. PER-01-09-2022 Motion to create a Part-Time Clinical Services Assistant Position

Rachel Bowlus made a motion to create a Part-Time Clinical Services Assistant position. DJ Mears seconded the motion.

Diane Krill explained this is a current intermittent position which is filled. This position works
more a Part-Time status than intermittent and requests this becomes a Part-Time position giving
the employee a chance to apply for the position at a Part-Time status. There is no change to the
budget or pay.

FINANCE - Nilgun Sezginis (30 minutes)

**Nilgun Sezginis read First reading by title only for the proposed Food Service Operation, Retail Food Establishment (FSO/RFE) fee revisions for 2023. Lana Glore explained to the board some items to note regarding a slight decrease in fees collected and decrease in inspections during the COVID Pandemic. DJ Mears commented its good to see things getting back to normal.

FIN-01-09-2022 Motion to approve an amendment for Contracted Vaccinators

Nilgun Sezginis made a motion to approve an amendment to the contracts with the independent contractor vaccinators to allow them to provide any vaccinations on behalf of WCHD, not just COVID vaccinations. All other terms of the agreement will remain unchanged. Richard Strow seconded the motion. A voice vote was taken. *Motion passed*

FIN-02-09-2022 Motion to authorize WCHD to purchase up to \$339,000 of Rapid COVID Tests

Nilgun Sezginis made a motion to authorize WCHD to spend up to \$339,000 to purchase rapid COVID test kits manufactured by Quidel, Abbot, or other similar manufacturer to support robust access to timely COVID testing in Wood County. WCHD will maintain current, competitive bids for rapid COVID tests and will purchase supplies to meet testing needs, as demonstrated by community demand and reports on availability through the supply chain. Cost per kit may vary, depending on the current market availability at the time of purchase. Cathy Nelson seconded the motion. A roll call vote was taken. *Motion passed*

FIN-03-09-2022: Motion to approve WIC Lease Agreement

Nilgun Sezginis made a motion to approve the Lease Agreement between Wood County Board of Commissioners and Wood County Board of Health effective 10/1/2022 through 9/30/2023 in the amount of \$23,463.00 annually or \$1,955.25 per month which would be due and payable on the first day of the month. This lease may be renewed for an additional three (3) one (1) year terms upon consent of both parties for leasing space at 639 Dunbridge Road, Bowling Green, Ohio for the WIC department. Updates and Reports (30 minutes)

Cathy Nelson inquired regarding Accounts Receivable and how the Centerprise consult went and the current plan when they would begin. Lexie stated we are waiting on the connection through IT adding they will begin working the AR as soon as access is granted. A brief discussion was held regarding patient incentives for new patients and bringing down no shows for dental patients.

- I. Ben Robison provided the Health Commissioner report with an update on vaccine availability of the latest adding a recent order of 1200 doses adding clinics continue to be offered here at the Health Department twice a week while supporting an Area Office of Aging event where 300 doses were provided. There will be an automated community outreach to go out to everyone 50+ who have received the previous vaccine series.
 - Building renovation update: 4 bids were received in search of a construction contractor and bids came in lower than anticipated. Discussion was held with the board regarding a breakdown of \$600,000 which included base bids and 3 alternate approaches and begin November 1st.
 - € Base Bid: \$483, 200;
 - € Alternate 1 Exam Room Painting: \$6,600
 - € Alternate 2: Corridor Painting: \$4,350
 - € Alternate: Phased Construction \$33,900
 - € Contingency: \$71, 950

- Ben updated the board on the Community Health Assessment and Community Health Improvement Plan status and alignment with the State Health Improvement Plan adding the plan is in its final stages of completion.
- Reaccreditation has been submitted to PHAB and in review by their team. Once feedback by their team is provided, we will have a 45 day window to respond to any corrective action.
- COVID outreach continues with messaging, vaccine clinics and supply of test kits. Monkey Pox is showing a national trend of diminishing transmission; Wood County has had to date a total of 2 cases. We are now a staging site for T-Pox which is an anti-viral medication for Monkey Pox which is six courses/treatments for the region.
- E-Coli outbreak earlier in the month ended up being a total of 23 cases. Although the investigation is still ongoing, CDC in cooperation with Wendy's made a national announcement they would be choosing a different romaine product for their sandwiches.
