GENERAL SUMMARY DESCRIPTION: The Community Outreach Coordinator is responsible for planning, creating and evaluating the Wood County Health Department's internal and external communications and community outreach programs. The Community Outreach Coordinator will support the development and execution of the Health Department's public information campaigns. The coordinator will also be responsible for identifying opportunities for community engagement including community meetings, events and other channels, and foster relationships with community-based organizations.

- Identify, build and maintain relationships with community partners, including community organizations, businesses and other diverse groups.
- Develop communication materials and campaigns, including press releases, newsletters, flyers, brochures, social and digital media content, and posters.
- Use print, digital and social media to promote the programs and services of the Health Department.
- Plan, coordinate and participate in community events.
- Gather, distill and disseminate public health information and information regarding Health Department activities.
- Serve as media contact for the Health District.
- Serve as Public Information Officer (PIO) during public health emergencies.
- Serve on regional and county committees, organizations and task forces regarding healthrelated matters as appropriate.
