The July 22<sup>nd</sup>, 2024, Special Meeting of the Board of Health was held in the board room of the Wood County Health Department to discuss and consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee, official, licensee, or regulated individual and to discuss and consider the health center's participation in the Accountable Care Organization (ACO) of the Ohio Association of Community Health Centers (OACHC).

## FIN-01-07-2024SPM Resolution to authorize the Health Center CEO to execute the ACO (Accountable Care Organization) Participant Agreement

Richard Strow motioned to approve the Health Center CEO, Lindsey Ruivivar, to execute the ACO Participant Agreement, pending Prosecutor's approval, to meet a July 31, 2024 deadline. This agreement will become effective January 1, 2025. Ohio health centers, acting through the Ohio Association of Community Health Centers (OACHC), have established an ACO to participate in the Medicare Shared Savings Program (MSSP) administered by the Centers for Medicare & Medicaid Services (CMS). By joining the ACO, the health center will be able to participate in the Medicare Shared Savings Program administered by the Centers for Medicare & Medicaid Services. As a participant, the health center will have the opportunity to receive shared savings payments for qualified Medicare patients as a benefit of adhering to quality assurance and improvement programs.
